Whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

- 2. And whereas, the SHIKHAR TEACHER TRAINING INSTITUTE, NEAR BASHERBA CHURCH, BEHIND SCHEME NO.36-A, BHOLYAWAS, NEEMACH 458441 MADHYA PRADESH by affidavit date. 12.01.2015 has consented to come under new Regulations and sought for two basic units in **B.Ed**, which require additional facilities.
- **3.** And whereas, it has been decided to permit the institution to have two basic units of 50 students each subject to the institution fulfilling following conditions namely:-
  - The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
  - II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.
- III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.
- IV. In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.

WHEREAS, recognition was granted to the institution, namely, SHIKHAR TEACHER TRAINING INSTITUTE RUN BY-SHRI SAI SHANKAR EDUCATION SOCIETY, SCHEME NO.36-A, GRAM-BHOLYAWAS, SAI SHANKAR VIDHYA NIKETAN PARISAR, TEHSIL+DISTRICT-NEEMACH, MADHYA PRADESH under section 14 of NCTE Act, 1993 for conducting B.ED. course (100 Intake) vide order dated 29.07.2008.

- 2. AND WHEREAS, the letter for AFFIDAVIT REGARDING ACCEPTANCE AND COMPLIANCE OF NCTE REGULATIONS, 2014 was issued to the institution on 17.01.2015 and the reply was received on 28-01-2015.
- 3. AND WHEREAS, Revised Recognition order was issued to the institution for two basic units of (50 students each) on 27.05.2015.
- 4. AND, WHEREAS, the matter was placed in 255<sup>th</sup> Meeting of WRC held on June 22-24, 2016 and the Committee decided that "...The agenda put up by the RD was examined by the Committee. The Committee agrees with the proposal to issue Show Cause Notices as proposed in the agenda item. In the agenda it was proposed to send SCN to all cases who have not compiled NCTE Regulations, 2014."
- 5. AND, WHEREAS, a Show cause notice was issued to the institution on 21.12.2016 for not submitting the following documents in compliance of Regulation 2014 mentioned in the revised order:
  - 1) Staff Profile for the session 2015-16 duly approved by the affiliating body.
  - 2) Originally notarized CLU/NEC/BP and Building Completion Certificate.
- 6. AND WHEREAS, the reply of show cause notice was submitted by the institution on 14.02.2017.
- 7. AND WHEREAS, the matter was placed in 310<sup>th</sup> Meeting of WRC held on August 19<sup>th</sup>-21<sup>st</sup>, 2019 and the Committee decided that "...The Show Cause Notice was issued to the institution vide letter dated 21/12/2016 and reply received on 14/02/2017.

The summary of the case reveals that the reply was not submitted within the stipulated time of 30 days as per the Show Cause Notice.

Moreover, the staff profile for approved intake CLU, Building Completion Certificate, Building Plan & NEC are also not submitted in original.

Hence, the committee decided to withdraw the recognition under Section 17(1) of the NCTE Act, 1993 for B.Ed. programme with effect from the end of the academic session next following the date of communication of the said order."

- 8. AND, WHEREAS, the withdrawal order was issued to the institution on 04.09.2019.
- 9. AND, WHEREAS, the institution filed an Appeal to NCTE, Hqrs. On 05.10.2019 and vied Appellate Order dated 13.12.2019 the Council hereby remanded back the case to the WRC, NCTE for necessary action.
- 10. AND WHEREAS, the matter was placed in 313th Meeting held on February 25th-27th, 2020 of WRC and the Committee decided that "...The Committee considered the matter keeping in view the order of the Appellate Authority dated 13.12.2019 and decided that the recognition of the institution be restored with the existing annual intake of two units (100 students)."
